Introduction

I am writing to invite you to the annual general meeting of the Company to be held at 4:00 p.m. on 4 April 2016 at 200 Strand, London, WC2R 1DJ. The notice of the Annual General Meeting is set out at the end of this document.

This letter also explains why the Directors recommend that shareholders of the Company (the "**Shareholders**") vote in favour of the resolutions being proposed at the Annual General Meeting (the "**Resolutions**").

Resolutions at the Annual General Meeting

Resolution 1 - Receiving and Considering the Accounts

Resolution 2 – Appointment of Director
